SECTION 4 -- FIRST AID MEASURES

Inhalation: IF INHALED: Remove victim to fresh air. If not breathing, give artificial respiration, preferable mouth-to-mouth. Get medical attention.

Ingestion: IF SWALLOWED: Call a doctor or get medical attention. Do not induce vomiting or give anything by mouth to an unconscious person. Drink promptly a large quantity of milk, egg white, gelatin solution, or if these are not available, drink large quantities of water. Avoid Alcohol.

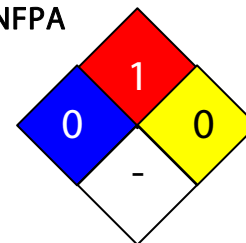

SECTION 6 -- ACCIDENTAL RELEASE MEASURES
