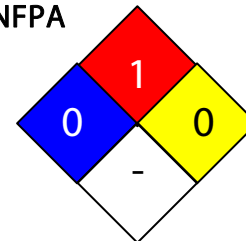
SECTION 4 -- FIRST AID MEASURES
